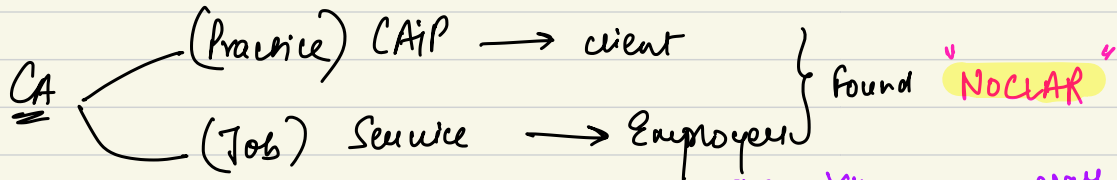


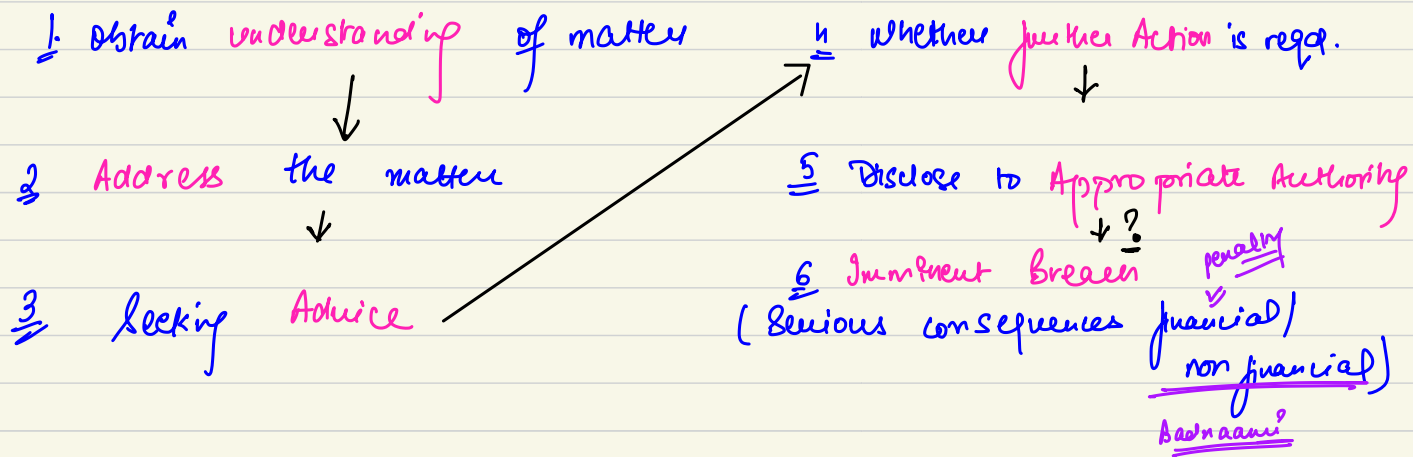
NOCLAR [Non-Compliance with Laws & Regulations]

Prohibited SEBI Act 1992

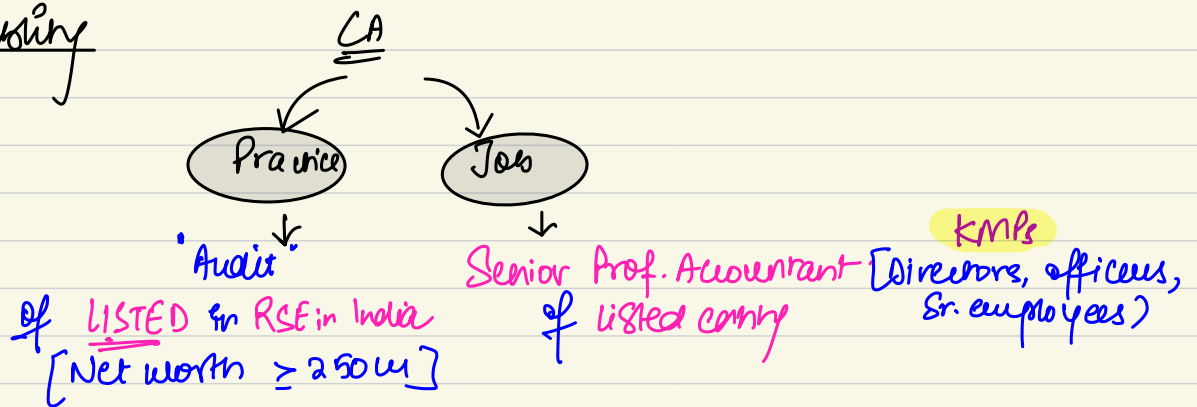

Q SA 250 vs. NOCLAR

SA 250

NOCLAR

Professional Accountants (Service/Practice)

Similar to SA 250 ⊕ non-compliance

- cause substantial harm (financial/non-financial terms)

In exceptional circumstances, when CA becomes aware of imminent danger → discuss (mgt & TCWG) ⊕

Investors, crs, employees, & general public → disclose appt. auth
